GENERAL INFORMATION:

The sport practiced at the aforementioned event is an extreme sport which may result in accidents, physical injuries or even death.

Therefore, participants must be in excellent physical and psychological condition and must have sufficient experience in order to be able to participate in all sports-related activities that are part of the event.

Condition precedent for the permission to participate in the event is the acceptance of this declaration. Every active participant in the event (hereinafter referred to as participant) must accept this declaration upon registration by signing it. If the participant is a minor, this declaration must be read and completed together with a parent. Moreover, the declaration must not only be signed by the minor, but also by his parent, for the minor to be allowed to participate in the event. The permission of the parent shall be deemed the consent to the minor participating in the event. The organizer does not incur any supervisory duties for minors or other participants without full legal capacity. Minors may only participate in the event when accompanied by an adult supervisor of full legal age and capacity.

Participation in the accompanying events is also deemed participation in the event.

HEALTH:

The participant confirms to be of excellent health. In case of limitations due to medical conditions that already existed prior to the event, these are listed below:

TRACK:

The participant is obliged to carefully familiarise himself/herself in advance with the conditions and course of the track as well as with the dangers the track poses before taking action.

INSTRUCTIONS AND RESERVATIONS:

The instructions of the organizers, stewards and security personnel must be observed. In particular, the organizer reserves the right to change the track at any time or to cancel the event. The protective equipment required by the organizer must be used. Participants violating the safety regulations of the organizer can be excluded from the event without being entitled to any compensation.

LIABILITY AND WAIVER OF CLAIMS:

By signing this declaration of consent, the participant declares that, in case of suffering an injury or any other damage during the event, he/she will not assert any legal claims towards other participants, the staff, the organizers, the landowners or the owners of streets and paths. The participant will indemnify and hold harmless all persons involved in the event in regard to any damage incurred by participating in the event. The organizer only assumes liability towards the participant for own culpability or culpability of its staff in cases of gross negligent or intent.

The organizer does not assume liability for the loss or theft of or damage to objects, valuables or cash, and the participant himself/herself shall be responsible for safe storage.

The participant confirms to have read this information carefully, to have understood it and to have completed this form truthfully.

IMAGE RIGHTS AND PERSONAL INFORMATION:

By signing this declaration of consent, the participant also grants the organizer the irrevocable right to utilize and to publish recordings (audio or video or images) made/taken by the organizer during the event for any permissible purpose without compensation and without time or geographical limitations.
